- 7.5 Clauses which expressly or by implication have effect after termination shall continue in full force and effect, including clause 1 (Definitions and interpretation), clause 7 (Consequences of termination), clause 8 (Limitation of liability and indemnities), and sub-clause 11,2 (Governing law and jurisdiction).

- 8.5 Subject to clause 8.4, under no circumstances shall the Organiser be liable to the Sponsor for any of the following, whether in contract, tort (including negligence) or otherwise:

 any indirect or consequential losses; loss of revenue or anticipated revenue; loss of savings or anticipated savings; loss of business opportunity; loss of profits or anticipated profits; or loss of wasted expenditure.
